ENGLISH INSTRUCTIONS FOR USE

FluoroDose® is a great-tasting, sodium fluoride varnish containing 50mg of sodium fluoride (equivalent to 22.6mg fluoride ion) per 1 ml. The convenient LoliTray™ single dose package allows easy mixing and application for uniform results.

Directions for use:

- Clean teeth and remove excess moisture from area to be treated.
- Grip the foil cover and slowly peel back, exposing the brush applicator and varnish well.
- Remove applicator brush and stir material in well.
- Paint a thin film of varnish onto treatment area.
- Let the varnish dry for approximately 10 seconds and then instruct the patient to close their mouth.
- Dispose package and applicator after use.
- Patient may leave immediately after treatment. Patient should be advised to remain on a soft food diet and only drink cold liquids for two hours after treatment; and not to brush for a minimum of 4 to 6 hours.
- When dry, any excess varnish may appear "spotty" and may slide off the tooth surface. This will not affect the efficacy of the product as there is still a full layer of varnish on the tooth.

Contraindications:

- Ulcerative gingivitis and stomatitis
- Known allergic reactions to fluoride
- Avoid ingestion during application
- Known allergies to colophony or similar materials

Interactions:

Do not apply when other fluoride treatments (gels or foams) are to be done on the same day. The use of fluoride tablets and rinses should be interrupted for several days after initial treatment.

Edematous swellings have been reported in rare instances, especially after application to extensive surfaces. Dyspnea, although extremely rare, has occurred in asthmatic patients. Patients with sensitive stomachs have reported nausea on occasion. Varnish may easily be removed through tooth brushing and rinsing.

Istruzioni per l'uso

FluoroDose è una vernice al fluororo di sodio dal gusto molto piacevole, contenente 50 mg di fluororo di sodio (equivalenti a 22,6 mg di ione fluororo) per ml. La comoda confezione monodose LoliTray™ permette una facile miscelazione e applicazione, per ottenere risultati uniformi.

Indicazioni per l'uso:

- Pulire i denti e rimuovere l'umidità in eccesso dall'area che deve essere trattata.
- Afferrare il rivestimento protettivo in alluminio e staccarlo lentamente, scoprendo bene il pennello applicatore e la vernice.

FRANÇAIS MODE D'EMPLOI

Réservé à l'usage professionnel

Utilisation:

FluoroDose est un vernis au fluorure de sodium au goût agréable contenant 50 mg de fluorure de sodium (équivalent à 22,6 mg d'ion de fluorure) par 1 ml. L'emballage à dose unique pratique LoliTray™ facilite le mélange et l'application pour des résultats uniformes.

Mode d'emploi:

- Nettoyer les dents et éliminer l'excédent d'humidité de la région à traiter.
- Saisir le film de protection et le tirer lentement pour mettre à nu la brosse applicatrice et le godet de vernis.
- Retirer la brosse applicatrice, la plonger dans le godet et mélanger.
- Appliquer un mince film de vernis sur la région à traiter.

Instrucciones de uso

FluoroDose es un barniz de fluoruro sódico y excelente sabor que contiene 50mg de fluoruro sódico (equivalente a 22,6mg de ión fluór) por 1 ml. Su presentación en cómodos envases de dosis única LoliTray™ facilita su mezclado y aplicación, lográndose unos resultados uniformes.

Forma de administración:

- Limpie los dientes y retire el exceso de humedad del área a tratar.
- Suelte lentamente la película protectora, liberando el cepillo aplicador y el barniz.
- Retire el cepillo aplicador y mezcle el material.
- Aplique una capa fina de barniz sobre el área a tratar.
- Deje que se seque el barniz durante aproximadamente 10 segundos y seguidamente pídale al paciente que cierre la boca.
- Elimine el envase y el aplicador tras su uso.
- El paciente puede abandonar la consulta después del tratamiento. Se debe recomendar al paciente que coma alimentos blandos y sólo ingiera líquidos fríos en las dos horas siguientes al tratamiento, y que no se cepille los dientes durante las primeras 4 a 6 hs, como mínimo.

Una vez seco, cualquier exceso de barniz puede presentar un aspecto “irregular” y resbalar sobre la superficie dental. Esto no afectará a la eficacia del producto, dado que todavía queda una capa completa de barniz en el diente.

Contraindicaciones:

- Gingivitis ulcerativa y estomatitis.

Interacciones:

SUOMI KÄYTTÖOHJEET

FluoroDose® 5% natriumfluoridilakka
Vain ammattimaiseen käyttöön

Käyttöohjeet

FluoroDose on hyvänmakuinen natriumfluoridilakka, joka sisältää 50 mg natriumfluoridia (vastaa 22,6 mg fluoridi-onia) per 1 ml. Kätevä LoliTray™-yksittäispakkaus mahdollistaa helpon sekoituksen ja levityksen, jolloin tulos on yhdenmukainen.

Käyttöohjeet:

- Puhdista hampaat ja poista ylimääräinen kosteus käsiteltävältä alueelta.
- Tartu kalvoon ja vedä se hitaasti irti, jolloin applikaattoriharja ja lakkakuppi tulevat näkyviin.
- Poista applikaattoriharja ja sekoita kupissa oleva aine.
- Levitä ohut kerros lakkaa käsiteltävälle alueelle.
- Anna lakan kuivua noin 10 sekuntia ja pyydä sen jälkeen potilasta sulkemaan suu.
- Hävitä pakkaus ja applikaattori käytön jälkeen.
- Potilas saa lähteä kotiin heti käsitellyn jälkeen. On suositeltavaa, että potilas ei nauti kahteen tuntiin muuta kuin pehmeää ruokaa ja kylmiä juomia eikä harjaa hampaitaan 4–6 tuntiin.
- Kun lakka on kuivunut, ylimääräinen lakka saattaa näyttää ”läiskäiseltä” ja irrota hampaan pinnasta. Tämä ei heikennä aineen vaikutusta, sillä hampaan pinnalle jää kerros lakkaa.

Vasta-aiheet:

- Haavainen ientulehdus ja stomatitis
- Tunnetut allergiset reaktiot fluoridille
- Vältettävä nielemistä levittämisen aikana
- Tunnetut allergiset reaktiot kolofonille tai vastaaville aineille

Yhteisvaikutukset:

Ei saa käyttää, mikäli samana päivänä käytetään muita fluoridipitoisia aineita (geelejä tai vaahtoja). Fluoritablettien ja -huuhteluiden käyttö on keskeytettävä useaksi päiväksi käsittelyn tekemisen jälkeen.

Haittavaikutukset:

Turvotuksesta on raportoitu harvoissa tapauksissa, etenkin, kun tuotetta on levitetty suurille alueille. Hengenahdistusta on esiintynyt astmaattisilla potilailla, vaikkakin erittäin harvoin. Herkkävatsaisten potilaiden on raportoitu kärsineen pahoinvoinnista. Lakka on helppo poistaa harjaamalla hampaat ja huuhtomalla suu.

PORTUGUÊS INSTRUÇÕES DE UTILIZAÇÃO

Instruções de utilização

FluoroDose é um verniz de fluoreto de sódio de paladar muito agradável, contendo 50 mg de fluoreto de sódio (equivalente a 22,6 mg de ião fluoreto) por 1 ml. A prática embalagem LoliTray™ de dose única permite uma mistura e aplicação fáceis, de modo a obter resultados uniformes.

Indicações de utilização:

- Limpar os dentes e remover o excesso de humidade da área a ser tratada.
- Levante o revestimento de alumínio e destaque-o lentamente, expondo a escova aplicadora e o reservatório de verniz.
- Remova a escova aplicadora e agite o material no reservatório.
- Aplique uma camada fina de verniz na área de tratamento.
- Deixe o verniz secar por cerca de 10 segundos e, depois, peça ao paciente para fechar a boca.
- Elimine a embalagem e o aplicador após a utilização.
- O paciente poderá ir-se embora imediatamente após o tratamento. O paciente deve ser aconselhando a manter uma dieta de alimentos moles e bebidas frias e a não escovar os dentes durante, no mínimo, 4 a 6 horas após o tratamento.

Quando seco, pode haver algum excesso de verniz (manchas) e escorrer da superfície do dente. Tal não afecta a eficácia do produto, dado que ainda permanece uma camada completa de verniz sobre o dente.

Contra-indicações:

- Gengivite e estomatite ulcerativas
- Reacções alérgicas conhecidas ao fluoreto
- Evitar a ingestão durante a aplicação
- Allergias conhecidas a colofonia ou materiais semelhantes

Interacções:

Não aplicar quando estão previstos outros tratamentos com fluoreto (em gel ou espuma) para o mesmo dia. Deve interromper-se o uso de comprimidos e elixires com fluoreto durante vários dias após o tratamento inicial.

Reacções adversas:

Foram notificadas tumefacções edematosas em circunstâncias raras, sobretudo após a aplicação em superfícies extensas. A dispnea, ainda que extremamente rara, ocorreu em pacientes asmáticos. Pacientes com o estômago sensível notificaram náusea ocasionalmente. O verniz pode ser facilmente retirado através de escovagem dos dentes e enxaguamento.

DANSK BRUGSANVISNING

FluoroDose® 5% natriumfluoridlak

Brugsanvisning

FluoroDose er en velsmagende natriumfluoridlak, der indeholder 50 mg natriumfluorid (svarende til 22,6 mg fluoridion) pr. 1 ml. Den bekvemme LoliTray™ enkeltdosisapakke muliggør nem blanding og applicering for at opnå ensartede resultater.

Brugsanvisning:

- Rengør tænderne, og fjern overskydende fugtighed fra det område, der skal behandles.
- Tag fat i folieovertrækket, og træk det langsomt tilbage, således at appliceringsbørsten og lakbrønden blotlægges.
- Fjern appliceringsbørsten og omrør materialet i brønden.
- Anbring en tynd film af lakken på behandlingsområdet.
- Lad lakken tørre i cirka 10 sekunder og bed derefter patienten lukke munden.
- Kasser pakken og appliceringsbørsten efter brug.
- Patienten kan gå umiddelbart efter behandlingen. Patienten skal rådes til at spise bløde fødevarer, kun drikke kold væske i to timer efter behandlingen og undlade at børste tænderne i mindst 4 - 6 timer.
- Når lakken er tør, kan der "pletvis" forekomme overskydende lak, som glider af tandoverfladen. Det forringer ikke effekten af produktet, da der stadig er et fuldstændigt lag lak på tanden.

Contraindikationer:

- Ulcerativ gingivitis og stomatitis
- Kendte allergiske reaktioner over for fluorid
- Undgå synkning under applicering
- Kendte allergier over for kolofonium eller lignende materialer

Interaktioner:

Bør ikke appliceres, når andre fluoridbehandlinger (gel eller skum) skal foretages på samme dag. Brugen af fluoridtabletter og -skyninger bør afbrydes i flere dage efter den første behandling.

Bivirkninger:

I sjældne tilfælde er der rapporteret edematøse hævelser, særligt efter applicering på store overflader. Der er blevet konstateret dyspnø hos astmapatienter, selvom det kun forekom i yderst sjældne tilfælde. Patienter med følsom mave har lejlighedsvis klaget over kvalme. Lakken kan let fjernes vedat pudse tænder og skylle munden med vand.

Gebruiksaanwijzing

FluoroDose is een goed smakende natriumfluoridevernis met 50 mg natriumfluoride (dat komt overeen met 22,6 mg fluoride-ionen) per ml. De handige LoliTray™-ééndosisverpakking maakt mengen en aanbrengen gemakkelijk, zodat u uniforme resultaten behaalt.

Het gebruik:

- Maak de tanden schoon en verwijder overtollig vocht van het te behandelen gebied.
- Pak de afdekfolie vast en trek deze langzaam van de verpakking, zodat de aanbrengborstel en de mengcup bloot komen te liggen.
- Verwijder de aanbrengborstel en roer het materiaal in de mengcup.
- Breng een dunne laag vernis aan op het te behandelen gebied.
- Laat het vernis gedurende ongeveer 10 seconden drogen en geef de patiënt vervolgens opdracht zijn/haar mond te sluiten.
- Werp de verpakking en de aanbrengborstel na gebruik weg.
- De patiënt kan onmiddellijk na de behandeling naar huis. Wel moet de patiënt worden aanbevolen gedurende twee uur na de behandeling alleen zacht voedsel te eten en alleen koude dranken te drinken en af te zien van tandenpoetsen gedurende minimaal de eerste 4 tot 6 uur.
